**NOTICE, AUTHORIZATION AND RELEASE
FOR THE PROCUREMENT OF A BACKGROUND CHECK**

In connection with my application for employment with Sushi with Gusto, Inc. ("SWG"), I hereby agree as follows:

1. General Consent To Background Investigation
